If a Council Member, staff member or member of the public wishes to discuss any item on the Consent Agenda, they can request the item be removed from the Consent Agenda for discussion. The remaining items on the Consent Agenda will be voted on with one motion being made for all items on the Consent Agenda. Then the item removed from the Consent Agenda will be separately considered and voted on.

Items identified with a double asterisk (\*\*) are quasi-judicial functions of the City Council other than land use; the Council Members disclose any ex parte communications.

**Groveland Code of Ordinances Sec. 2-58 (f).** Any person desiring to address the Council shall first secure the permission of the presiding officer and shall give his name and address for the record. All remarks shall be addressed to the Council as a body and not to any member thereof unless permission to do so is first granted by the presiding officer. #### **GENERAL SUMMARY/BACKGROUND:**

Pursuant to Florida Statutes 200.065(1), the City sets a not-to-exceed millage rate of 5.2000. During the course of the budget workshops and meetings, the City Council desired to keep the millage rate at this level or lower. Staff designed a budget based on a 5.2000 millage rate and has been able to provide a balanced budget for the City Council. This keeps the millage rate to the same as the current year.

#### **BUDGET IMPACT:**

Levying an ad-valorem millage rate of 5.2000 mills will generate \$5,534,382 in property tax revenue

**ORDINANCE 2020-34**

**AN ORDINANCE ADOPTING A MILLAGE RATE OF 5.2000 PER \$1,000.00 VALUATION FOR REGULAR AD VALOREM TAXES TO BE LEVIED DURING THE FISCAL YEAR OF THE CITY OF GROVELAND, FLORIDA FROM OCTOBER 1, 2020 THROUGH SEPTEMBER 30, 2021 AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, , a public hearing was held on September 8, 2020 and September 21, 2020 as to the ad valorem millage rate and budget for fiscal year October 1, 2020 through September 30, 2021; and

**WHEREAS**, the second public hearing was duly advertised in the Orlando Sentinel as required by Florida Statute, Chapter 200 and Florida Statute, Section 166.041; and

**WHEREAS**, at such public hearing it was determined that the millage for the City of Groveland, Florida fiscal year October 1, 2020, through September 30, 2021, should be set at 5.2000 per \$1,000.00 valuation for regular ad valorem taxes;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GROVELAND, LAKE COUNTY, FLORIDA, as follows:**

**SECTION 1.** That the City Council of the City of Groveland, Florida hereby levies a millage rate of 5.2000 per \$1,000.00 valuation for regular ad valorem taxes on real and tangible personal property within the municipality for the fiscal year October 1, 2020 through September 30, 2021.

**SECTION 2.** The millage rate of 5.2000 for fiscal year October 1, 2020 through September 30, 2021, represents a 6.11% increase over the roll back ad valorem rate of 4.9008 for the fiscal year ending September 30, 2020.

**SECTION 3.** The City Manager of the City of Groveland is hereby directed to forward a copy of the Ordinance adopting the aforesaid millage rate to the Lake County Property Appraiser, the Lake County Tax Collector, and the Department of Revenue of the State of Florida.

**SECTION 4.** This Ordinance becomes effective immediately upon its adoption by the City Council of the City of Groveland, Florida.

**GENERAL SUMMARY/BACKGROUND:**

The total operating budget for the City of Groveland is \$94,673,827. The budget was developed using a millage rate of 5.2000 per \$1,000 of valuation and maintains reserves of 20% or greater of projected operating expenses. The budget was developed utilizing multiple meetings with staff, council and workshops and is divided into 6 major fund types. Below is the budget totals by fund type.
