

RESOLUTION 2021-02

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GROVELAND, FLORIDA, ADOPTING A FEE SCHEDULE FOR FLOOD ZONE DETERMINATION AND FLOOD DEVELOPMENT PERMIT; REPEALING ANY FEES IN CONFLICT HEREWITH; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Groveland adopted a Floodplain Management program in Chapter 121, Code of Ordinance;

WHEREAS, Chapter 121, Code of Ordinances provides for a floodplain administrator who is authorized and directed to administer and enforce the provisions of the chapter; and

WHEREAS, the City of Groveland is authorized to impose fees sufficient to pay the costs associated with administering the program; and

WHEREAS, the City Council finds that the fees set forth shall be imposed in accordance with law.

THEREFORE BE IT RESOLVED by the City Council of the City of Groveland, Florida, as follows:

1. The above recitals are true and correct and, by this reference, are hereby incorporated into and made an integral part of this resolution.
2. City Council adopts the following fees for Flood Plain Management Program*:

Flood Zone Determination (Clearance)	\$25.00 each
Flood Development Permit (for structures and activities that fall within the flood hazard areas)	\$150.00 each
Flood Development Re-Review Fee (when another review is required due to an applicant error)	\$25.00
Flood/FEMA MT-1 Form (LOMR-F, CLOMR-F) Single Lot/Single Structure	\$180.00
Flood/FEMA MT-1 Form (LOMR-F, CLOMR-F) Multiple Lots/Multiple Structures	\$250.00
Flood/FEMA MT-2 Form (LOMR-F, CLOMR-F) Up to and including 100 acres	\$1600.00
Flood/FEMA MT-2 Form (LOMR-F, CLOMR-F) Greater than 100 acres	\$2,000.00

* Conditional Letter of Map Revision (CLOMR); Letter of Map Revision (LOMR)

3. All other ordinances or resolutions, or parts of ordinances or resolutions, in conflict herewith are repealed.

4. This resolution shall be effective immediately upon adoption.
